

Description 11.700 acre parcel

Being a part of Lot 15 of the First Quarter, Berlin Township, T-9 N, R-6 W, Holmes County, Ohio, also known as part of the lands conveyed to Daniel D. and Velma Mast in Deed vol. 273 page 707, PN 0100297005.

Described as follows:

Commencing at a R.R. spike found in the center of T.R. 351 marking the northwest corner of said Lot 15, thence S 00 degrees 40' 25" W 914.57 feet along the lot line and along the centerline of T.R. 351 to a point the TRUE POINT OF BEGINNING, witnessed by an iron pin set S 88 degrees 12' 11" E 25.00 feet.

thence with the following EIGHT (8) COURSES:

- 1) S 88 degrees 12' 11" E 1123.19 feet through the lands of said Mast to an iron pin set;
- 2) N 00 degrees 40' 25" E 271.53 feet through the lands of said Mast to an iron pin set;
- 3) S 88 degrees 12' 11" E 231.88 feet through the lands of said Mast to an iron pin set;
- 4) N 00 degrees 40' 25" E 643.04 feet through the lands of said Mast to an iron pin set on the lot line;
- 5) S 88 degrees 12' 11" E 391.73 feet along the lot line to a 5/8 inch rebar found;
- 6) S 00 degrees 31' 41" W 964.63 feet along James Jay and Mary E. Mast (Deed vol. 273 page 859) and Daniel M. and Lisa R. Schlabach's (O.R. vol. 183 page 2245) west line to a 5/8 inch rebar found;
- 7) N 88 degrees 12' 11" W 1749.25 feet along Brenda L. Clark (Deed vol. 273 page 730) and Steven P. Clark and Carmen D. Clark's (O.R. vol. 252 page 1187) north line and along the north line of Lot 1 and Lot 2 of TR 351 Subdivision (P. 19-2700) to a point on the lot line and in the center of T.R. 351, witnessed by a 5/8 inch rebar found S 88 degrees 12' 11" E 30.00 feet;
- 8) N 00 degrees 40' 25" E 50.01 feet along the lot line and along the centerline of T.R. 351 to the TRUE POINT OF BEGINNING.

This parcel contains 11.700 acres, but subject to all highways and easements of record.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker 6938".
