

Description 4.852 acre parcel

Being a part of Lot 21 of the Fourth Quarter, Berlin Township, T-9 N, R-6 W, Holmes County, Ohio, also known as part of the lands conveyed to Gertie Miller, Lydia Ann Miller and Bennie E. Mullet in Official Record vol. 274 page 6836, PN 0100531001.

Described as follows:

Commencing at a point on the Mechanic Township line marking the southwest corner of said Lot 21, thence N 02 degrees 09' 35" E 155.77 feet along the lot line to a point, thence N 66 degrees 41' 32" E 784.43 feet along Bennie E. Mullet and Esther Mullet's (O.R. vol. 37 page 208) south line to a 5/8 inch rebar found, thence N 54 degrees 40' 40" E 888.11 feet along said Bennie E. Mullet and Esther Mullet's south line to a 5/8 inch rebar found the TRUE POINT OF BEGINNING.

thence with the following SIX (6) COURSES:

- 1) N 46 degrees 15' 30" W 842.14 feet along said Bennie E. Mullet and Esther Mullet's east line to a 5/8 inch rebar found;
- 2) N 68 degrees 33' 31" E 212.28 feet along said Bennie E. Mullet and Esther Mullet's east line to a point in T.R. 355 and on said Miller, Miller and Mullet's (O.R. vol. 274 page 6836 – PN 0100531000) westerly line, witnessed by a 5/8 inch rebar found S 68 degrees 33' 31" W 23.30 feet;
- 3) S 56 degrees 32' 51" E 440.92 feet along said Miller, Miller and Mullet's west line and along T.R. 355 to a point;
- 4) S 56 degrees 14' 37" E 331.84 feet along U.S. Riffenmat Land, Ltd.'s (O.R. vol. 211 page 93) west line and along T.R. 355 to a point, witnessed by an iron pin set S 32 degrees 20' 26" W 36.01 feet;
- 5) S 32 degrees 20' 26" W 144.58 feet through the lands of said Miller, Miller and Mullet's (PN 0100531001) to an iron pin set;
- 6) S 54 degrees 40' 39" W 190.71 feet through the lands of said Miller, Miller and Mullet to the TRUE POINT OF BEGINNING.

This parcel contains 4.852 acres, but subject to all highways and easements of record.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker 6938". Basis of bearings from Plat vol. 17 page 211.
