Description of 7.447 Acres

Situated in the Township of Clark, the County of Holmes, the State of Ohio.

Being located in the South Half of the Southeast Quarter of Section 21 in Township 8, Range 5 and being a part of the lands heretofore conveyed to Tusco Land Company, Ltd. in Official Record 247 at Page 1510 (AP #03-00029.006) with the tract to be conveyed being more fully described as follows:

Commencing at a stone monument found at the northwest corner of the south half of the southeast quarter of said Section 21 and being also at the **TRUE PLACE OF BEGINNING** of the tract herein to be described;

Thence with the north line of said south half South 88 deg. 29 min. 57 sec. East, 431.00 feet to an iron pin set;

Thence through the bounds of the aforesaid parent tract the following five courses;

- (1) thence South 6 deg. 59 min. 50 sec. West, 236.04 feet to an iron pin set;
- (2) thence South 13 deg. 07 min. 16 sec. East, 229.67 feet to an iron pin set;
- (3) thence South 71 deg. 12 min. 38 sec. East, 304.77 feet to an iron pin set;
- (4) thence North 83 deg. 33 min. 04 sec. East, 538.73 feet to an iron pin set;
- (5) thence North 85 deg. 53 min. 44 sec. East, 148.11 feet to a point in T.R. #177 - 60' R/W on the west bound of the lands heretofore conveyed to Tusco Land Company Ltd. (O.R. 241 - Pg. 970) and passing on line an iron pin set at 123.11 feet;

Thence with said road and with the bounds of said Tusco Land Company Ltd. lands South 27 deg. 30 min. 04 sec. East, 27.24 feet to a point at the northwest corner of the lands heretofore conveyed to L & M Mineral Company (O.R. 247 - Pg. 1513) and being also at the intersection of said road and T.R. #175 - 30' R/W;

Thence continuing with said T.R. #177 - 60' R/W and with a west bound of said L & M Mineral Company lands South 30 deg. 34 min. 09 sec. East, 27.93 feet to a point;

Thence leaving said road and through the bounds of the aforesaid parent tract the following four courses;

- (1) thence South 85 deg. 53 min. 44 sec. West, 170.35 feet to an iron pin set and passing on line an iron pin set at 25.00 feet;
- (2) thence South 83 deg. 33 min. 04 sec. West, 548.90 feet to an iron pin set;
- (3) thence North 71 deg. 12 min. 38 sec. West, 315.97 feet to an iron pin set;

(4) thence South 62 deg. 17 min. 45 sec. West, 514.38 feet to an iron pin set on the west line of the aforesaid south half of the southeast quarter of Section 21;

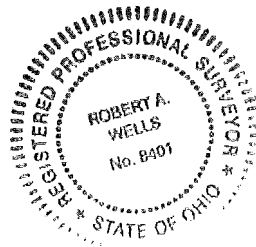
Thence with said west line of said south half North 1 deg. 18 min. 35 sec. East, 755.91 feet to the **TRUE PLACE OF BEGINNING**, containing 7.447 Acres, more or less but subject to all legal highways, rights-of-way, easements, leases and restrictions of record or otherwise legally established.

The above-described tract consists of part of AP #03-00029.006.

Bearings herein are oriented to Ohio State Plane North Zone-NAD 83 and all iron pins set are 5/8"x30" re-bars with blue plastic caps stamped R.A. W. 8401.
