[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Holmes, Village of Millersburg, and being a part of the Northeast Quarter of Section 19, Township 9, Range 7,

Being part of Out Lot 83 conveyed to Midflow Holdings, LTD. by Volume 258, Page 1488 of Holmes County Official Records, being on the left side of a centerline of right of way of United States Route 62, State Route 83 and South Washington Street, 50 foot right of way, project HOL-SOUTH WASHINGTON STREET SIDEWALKS and bounded and described as follows:

Beginning for the same at a 2 inch iron pipe found, known as the Southwest corner of the Northeast Quarter of Section 19;

Thence S 88° 14' 47" E, 518.50 feet along the quarter section line to a point in the centerline of right of way of South Washington Street being Station 1050+61.98;

Thence N 09° 46' 58" W, 118.03 feet along the centerline of right of way of South Washington Street to a point being station 1051+80.01, said point also being a southeasterly corner of the lands conveyed to Millersburg MHP LLC (O.R.V-282, P-2589);

Thence N 88° 40' 39" W, 25.48 feet along the southerly line of said Millersburg MHP LLC lands to a point in the existing westerly right of way line of South Washington Street and at the Grantor's northeast corner being 25.00 feet left of and at right angles to centerline of right of way station 1051+84.92, and the True Place of Beginning of the parcel herein described;

Thence with the following SIX courses:

- 1) **S 09° 46' 58" E, 108.05** feet along the existing westerly right of way line of South Washington Street and the Grantor's easterly line to a point being 25.00 feet left of and at right angles to centerline of right of way station 1050+76.87;
- 2) **N 88° 11' 38" W, 5.10** feet along the Grantor's southerly line to a MAG nail set being 30.00 feet left of and at right angles to centerline of right of way station 1050+77.89;
- 3) **N 04° 26' 41" W, 32.25** feet to an iron pin set being 27.00 feet left of and at right angles to centerline of right of way station 1051+10.00;
- 4) **N 09° 46' 58" W, 55.00** feet to an iron pin set being 27.00 feet left of and at right angles to centerline of right of way station 1051+65.00;
- 5) **N 17° 57' 01" W, 21.12** feet to a point in the Grantor's northerly line and southerly line of said Millersburg MHP LLC lands being 30.00 feet left of and at right angles to centerline of right of way station 1051+85.90;
- 6) **S 88° 40' 39" E, 5.09** feet along the Grantor's northerly line and the southerly line of said Millersburg MHP LLC lands to the place of beginning and containing 0.007 of an acre, more or less.


