

Description 0.688 acre parcel

Being part of the northeast quarter of Section 20, Knox Township, T-19 N, R-15 W, Holmes County, Ohio, also known as all of the lands conveyed to Rodney Tyler Jones in Official Record vol. 286 page 4160, PN 1000109002.

Described as follows:

Commencing at a point marking the southwest corner of the northeast quarter of Section 20, thence N 86 degrees 30' 09" E 417.52 feet along the quarter section line to a point on the west line of C.R. 23 and on Holmes County Board of Commissioners' (O.R. 277 page 5981) west line, thence N 12 degrees 24' 22" E 112.06 feet along the west line of C.R. 23 and along said Holmes County Board of Commissioners' west line to a point, thence along a curve to the left having a delta angle of 02 degrees 16' 50", R – 1880.00 feet, T – 37.42 feet, Ch. Brg. – N 11 degrees 15' 57" E, Ch. – 74.83 feet along the west line of C.R. 23 and along said Holmes County Board of Commissioners' west line an arc distance of 74.83 feet to a 5/8 inch rebar found the TRUE POINT OF BEGINNING.


thence with the following SEVEN (7) COURSES:

- 1) Along a curve to the right having a delta angle of 13 degrees 14' 29", R – 185.99 feet, T – 21.59 feet, Ch. Brg. – N 47 degrees 51' 47" W, Ch. – 42.89 feet along the north line of Valley Drive and along October Hill Camplot Owners' Association's (D.V. 216 page 875) north line an arc distance of 42.98 feet to a 5/8 inch rebar found;
- 2) N 41 degrees 14' 32" W 133.49 feet along the north line of Valley Drive and along said October Hill Camplot Owners' Association's north line to a 5/8 inch rebar found;
- 3) N 50 degrees 53' 28" E 80.98 feet along Holmes County Board of Commissioners' (D.V. 227 page 297) east line to a 5/8 inch rebar found;
- 4) N 14 degrees 40' 55" E 69.40 feet along said Holmes County Board of Commissioners' east line to a 5/8 inch rebar found;
- 5) N 39 degrees 06' 32" W 121.00 feet along said Holmes County Board of Commissioners' north line to a 5/8 inch rebar found;
- 6) N 89 degrees 40' 41" E 144.95 feet along Lakeview Holdings, Ltd.'s (O.R. 204 page 2777) south line to a 5/8 inch rebar found on the west line of C.R. 23 and on Holmes County Board of Commissioners' (O.R. 277 page 5981) west line;
- 7) Along a curve to the right having a delta angle of 10 degrees 28' 40" W, R – 1880.00 feet, T – 172.38 feet, Ch. Brg. – S 04 degrees 53' 12" W, Ch. – 343.32 feet along the west line of C.R. 23 and along said Holmes County Board of Commissioners' west line an arc distance of 343.80 feet to the TRUE POINT OF BEGINNING.
