

Description - Lot 2

Being Lot 2 of Paint Township Subdivision No. 9 recorded in Plat Book 19
Page 4366, of the Holmes County Plat Records.

Lot 2 contains 10.000 acres, but is subject to all highways and easements of record.

Paint Township Subdivision No. 9 is situated in Fractional Section 3, Paint Township, T-14 N, R-11 W, Holmes County, Ohio.

Note: Lot 2 is subject to all Restrictive Covenants listed or shown on said Subdivision Plat.

Note: Lot 2 has access by a 50 foot common access easement for the purpose of ingress, egress and general utilities and further described as follows:

Being a part of Fractional Section 3, Paint Township, T-14 N, R-11 W, Holmes County, Ohio, also known as part of the lands conveyed to Reuben A. Hershberger and Rosanna J. Hershberger in Official Record vol. 275 page 2361, PN 1500153002.

Commencing at a 5/8 inch rebar found marking the northwest corner of Fractional Section 3, thence S 89 degrees 36' 29" E 2061.80 feet along the section line to a 5/8 inch rebar found, thence S 00 degrees 14' 41" E 1376.93 feet along Kathy D. Schneider, Trustee's (O.R. 204 page 2945 and O.R. 263 page 2779) east line to a point in the center of T.R. 670, thence N 85 degrees 36' 33" E 358.88 feet along the centerline of T.R. 670 to a mag nail found, thence N 81 degrees 54' 36" E 98.12 feet along the centerline of T.R. 670 to a R.R. spike found, thence N 75 degrees 29' 37" E 48.21 feet along the centerline of T.R. 670 to a point the TRUE POINT OF BEGINNING.

thence with the following FIVE (5) COURSES along the centerline of a 50 foot common access easement:

- 1) S 28 degrees 03' 50" W 115.70 feet through the lands of said Hershberger to a point;
- 2) S 51 degrees 33' 55" W 203.87 feet through the lands of said Hershberger to a point;
- 3) S 00 degrees 55' 22" E 104.89 feet through the lands of said Hershberger to a point;
- 4) S 19 degrees 15' 32" E 410.30 feet through the lands of said Hershberger to a point;
- 5) S 05 degrees 08' 24" W 95.00 feet through the lands of said Hershberger to a point on the north line of said Lot 2 and THERE ENDS

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker Surveying LLC".
