Being part of Salt Creek Township, Southwest Quarter of Section 33, T-15 N,R-12 W, Holmes County, Ohio, also being part of the lands of Leroy A. Miller and Amy Miller in O.R. Vol. 271 Page 5264, PPN 2400384000.

Described as follows:

Commencing at a railroad spike found marking the northwest corner of the southwest quarter of section 33 witnessed by a 5/8 inch rebar found S 00 degrees 40'37" E at a distance of 40.00 feet thence **N 88 degrees 43'02" E a distance of 300.00 feet** along the quarter section line and along the centerline of T.R. 606 to a point witnessed by a 5/8 inch rebar found S 00 degrees 40'37" E at a distance of 15.51 feet being the TRUE PLACE OF BEGINNING.

Thence with the following **SEVEN (7) COURSES**;

1. **N 88 degrees 43'02" E a distance of 618.29 feet** along the quarter section line and along the centerline of said road to a railroad spike set;
2. **S 03 degrees 57'32" E a distance of 358.15 feet** through the lands of said Leroy A. Miller and Amy Miller and along the centerline of T.R. 611 to a point witnessed by an iron pin set S 89 degrees 25'12" W at a distance of 36.57 feet;
3. **S 89 degrees 25'12" W a distance of 219.58 feet** through the lands of said Leroy A. Miller and Amy Miller to an iron pin set;
4. **N 87 degrees 01'01" W a distance of 150.94 feet** through the lands of said Leroy A. Miller and Amy Miller to an iron pin set;
5. **N 82 degrees 35'27" W a distance of 157.33 feet** through the lands of said Leroy A. Miller and Amy Miller to an iron pin set;
6. **N 77 degrees 11'48" W a distance of 115.97 feet** through the lands of said Leroy A. Miller and Amy Miller to an iron pin set;
7. **N 00 degrees 40'37" W a distance of 291.86 feet** along the east line of Ivan Stutzman Jr., trustee and Susanna Stutzman, trustee (O.R. Vol. 267 Page 4888) to the TRUE PLACE OF BEGINNING.

This parcel contains 4.900 acres and is subject to all highways, easements, and restrictions of record.


