Vol. 169 Page 1931 (PPN 2601083000), (PPN 2600909003), (PPN 2600886005), and part of the lands of Jeffrey A. Miller and Anita Faythe Miller in O.R. Vol. 256 Page 1581 (PPN 2600886008).

Described as follows:

Commencing at a 5/8 inch rebar found capped "Baker" marking the southwest corner of the northeast quarter of the northeast quarter of section 5, thence N 00 degrees 23'37" E a distance of 458.79 feet along the west line of Hamsher Family Land Company, LLC (O.R. Vol. 264 Page 6167) to a point witnessed by a 3/4 inch rebar found S 63 degrees 02'11" W a distance of 0.66 feet being the TRUE PLACE OF BEGINNING;

Thence with the following TEN (10) COURSES;

1. **S 83 degrees 25'54" W a distance of 196.32 feet** along the north line of Hamsher Family Land Company, LLC (O.R. Vol. 264 Page 6167) to an iron pin set;
2. **N 42 degrees 36'12" W a distance of 130.23 feet** along the north line of said Hamsher Family Land Company, LLC to a point in the centerline of County Road 140 witnessed by a 3/4 inch rebar found S 42 degrees 36'12" E a distance of 17.71 feet;
3. **N 48 degrees 21'16" E a distance of 346.14 feet** along the east lines of Larry J. Troyer, trustee and Esther A. Troyer, trustee (O.R. Vol. 260 Page 6668), Mark R. and Fannie Troyer (Deed Vol. 279 Page 240), and along the centerline of said road to a point;

4. **S 28 degrees 50'53" E a distance of 283.31 feet** through the lands of said Jeffrey A. and Anita Faythe Miller to an iron pin set passing over an iron pin set at a distance of 21.34 feet;
5. **S 53 degrees 56'23" E a distance of 92.16 feet** through the lands of said Jeffrey A. and Anita Faythe Miller to an iron pin set;

8. **S 11 degrees 33'19" E a distance of 330.58 feet** along the west line of said Roy A. Kline and Rachel R. Kline to a 5/8 inch rebar found;
9. **S 25 degrees 22'03" W a distance of 105.08 feet** along the north line of Roy A. and Rachel R. Kline (O.R. Vol.164 page 846) to a 5/8 inch rebar found;
10. **N 36 degrees 24'57" W a distance of 488.91 feet** along the east line Hamsher Family Land Company, LLC (O.R. Vol. 264 Page 6167) to the TRUE PLACE OF BEGINNING.


This parcel contains 3.223 acres and is subject to all highways, easements, and restrictions of record.
