

Description 6.955 acre parcel

Being part of the northwest quarter of Section 6, T-8 N, R-5 W, Clark Township, Holmes County, Ohio, also known as part of the lands conveyed to Robert M. Barkman and Betty Barkman in Deed vol. 236 page 144, PN 3300009000 and PN 3300008000.

Described as follows:

Commencing at a 3/4 inch pipe found marking the southwest corner of the northwest quarter of Section 6, thence N 00 degrees 29' 46" E 736.15 feet along the section line to a stone found, thence N 51 degrees 50' 05" E 419.50 feet along Leah L. Karbler, Trustee's (O.R. 251 page 5906) south line to an iron pin set the TRUE POINT OF BEGINNING.

thence with the following EIGHT (8) COURSES:

- 1) N 51 degrees 50' 05" E 405.92 feet along said Karbler's south line to a 5/8 inch rebar found;
- 2) S 37 degrees 07' 55" E 380.76 feet along Matthew D. Yoder and Leigh Ann Yoder's (O.R. 251 page 4636) west line to a 5/8 inch rebar found;
- 3) N 50 degrees 10' 05" E 289.68 feet along said Yoder's south line to a 5/8 inch rebar found on Paul S. Erb and Elizabeth Erb's (D.V. 250 page 247) west line and in T.R. 154, witnessed by a 5/8 inch rebar found S 50 degrees 10' 05" W 26.78 feet;
- 4) S 37 degrees 07' 55" E 295.75 feet along said Erb's west line and along T.R. 154 to a R.R. spike set;
- 5) S 51 degrees 50' 34" W 535.98 feet along Adam M. Yoder and Christina Sue Yoder's (O.R. 259 page 2650) north line and along C.R. 19 to a point, witnessed by an iron pin set N 42 degrees 11' 29" W 6.00 feet;
- 6) N 42 degrees 11' 29" W 355.78 feet through the lands of said Barkman to an iron pin set;
- 7) S 51 degrees 31' 42" W 117.98 feet through the lands of said Barkman to an iron pin set;
- 8) N 38 degrees 57' 23" W 313.65 feet through the lands of said Barkman to the TRUE POINT OF BEGINNING.

This parcel contains 6.955 acres, but subject to all highways and easements of record.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker Surveying LLC".
Basis of bearings from Ohio State Plane Coordinate System, North Zone, N.A.D. 83, 2011 adjustment.
