Description: **0.872 Acres “to go to adjoinder”**

Being part of the Northwest Quarter of Section 1, Salt Creek Township, T-14 N, R-12 W, Holmes County, Ohio, also known as part of Lot 34 of the Hopeview Subdivision Allotment No. 1, Third Addition (Plat Vol. 19 Page 2710) of Willis O. Mast and Verna A. Mast in O.R. Vol. 252 Page 5871 (PPN 3400249003).

Further described as follows;

Commencing at a 5/8 inch rebar found marking the southeast corner of the northwest quarter of section 1, thence **N 00 degrees 32'53" W a distance of 1981.57 feet** along the quarter section line to a point, thence **S 89 degrees 25'36" W a distance of 78.82 feet** along the south line of Lot 30 of the Hopeview Subdivision Allotment No. 1, Second Addition, Replat of Lot 26 and Additional Land (Plat Vol. 2 Page 384) of David A. Miller and Marie Miller (O.R. Vol. 176 Page 397) to a 5/8 inch rebar found capped “Baker” being the TRUE PLACE OF BEGINNING.

1. **S 17 degrees 12'53" E a distance of 52.19 feet** along the west line of Lot 35 of the Hopeview Subdivision Allotment No. 1, Third Addition (Plat Vol. 19 Page 2710) of Owen E. Mast and Laura Mast (O.R. Vol. 252 Page 5873) to a 5/8 inch rebar found capped “Baker”;
2. **S 89 degrees 25'36" W a distance of 338.78 feet** along the north line of said Lot 35 of the Hopeview Subdivision Allotment No. 1, Third Addition of Owen E. Mast and Laura Mast to an iron pin set;
3. **N 00 degrees 17'42" W a distance of 50.00 feet** through the lands of said of Lot 34 of the Hopeview Subdivision Allotment No. 1, Third Addition of Willis O. Mast and Verna A. Mast to an iron pin set;

4. **N 89 degrees 25'36" E a distance of 271.40 feet** along the south line of Lot 33 of the Hopeview Subdivision Allotment No. 1, Second Addition, Replat of Lot 31 (Plat Vol. 19 Page 1136) of Willis D. Miller and Anna Kathryn Miller (O.R. Vol. 249 Page 2471) to a 5/8 inch rebar found capped "Baker";
5. **N 17 degrees 12'53" W a distance of 444.90 feet** along the east line of said Lot 33 of the Hopeview Subdivision Allotment No. 1, Second Addition, Replat of Lot 31 of Willis D. Miller and Anna Kathryn Miller to a 5/8 inch rebar found;
6. **S 63 degrees 49'23" E a distance of 68.81 feet** along the south line of said Lot 30 of the Hopeview Subdivision Allotment No. 1, Second Addition, Replat of Lot 26 and Additional Land of David A. Miller and Marie Miller to a 5/8 inch rebar found;
7. **S 17 degrees 12'53" E a distance of 412.57 feet** along the west line of said Lot 30 of Hopeview Subdivision Allotment No. 1, Second Addition, Replat of Lot 26 and Additional Land of David A. Miller and Marie Miller to THE TRUE PLACE OF BEGINNING.
