

Description 20.886 acre parcel

Being a part of the northeast quarter of Section 9, Salt Creek Township, T-14 N, R-12 W, Holmes County, Ohio, also known as part of the lands conveyed to Junior A. Stutzman and Emma A. Stutzman, trustees in Official Record vol. 149 page 397 and Official Record 149 page 399, PN 3400496000.

Described as follows:

Commencing at a 5/8 inch rebar found in T.R. 605 marking the northeast corner of the northeast quarter of Section 9, thence S 00 degrees 09' 30" W 1015.28 feet along the section line to an iron pin set the TRUE POINT OF BEGINNING.

thence with the following TEN (10) COURSES:

- 1) S 00 degrees 09' 30" W 745.89 feet along the section line to an iron pin set;
- 2) S 89 degrees 19' 53" W 948.21 feet partly along Weaver Real Estate Holdings, Ltd. (O.R. 7 page 469 and O.R. 63 page 88) and Paul A. Stutzman, trustee and Ella A. Stutzman, trustee's (O.R. 225 page 1447) north line to an iron pin set;
- 3) N 24 degrees 09' 35" W 370.86 feet through the lands of said Junior A. Stutzman and Emma A. Stutzman, trustee to an iron pin set;
- 4) S 89 degrees 19' 54" W 592.89 feet through the lands of said Stutzman to an iron pin set;
- 5) S 57 degrees 22' 47" W 70.20 feet through the lands of said Stutzman to a point in the center of C.R. 201, witnessed by an iron pin set N 57 degrees 22' 47" E 21.80 feet;
- 6) N 32 degrees 11' 13" W 50.00 feet along the centerline of C.R. 201 to a point, witnessed by an iron pin set N 57 degrees 22' 47" E 24.89 feet;
- 7) N 57 degrees 22' 47" E 551.45 feet through the lands of said Stutzman to an iron pin set;
- 8) S 31 degrees 45' 41" E 79.35 feet through the lands of said Stutzman to an iron pin set;
- 9) N 67 degrees 21' 39" E 471.33 feet through the lands of said Stutzman to an iron pin set;
- 10) N 89 degrees 19' 54" E 839.42 feet through the lands of said Stutzman to the TRUE POINT OF BEGINNING.

This parcel contains 20.886 acres, but subject to all highways and easements of record.

All iron pins set are 5/8 inch rebars with a plastic identification cap marked "Baker 6938". Bearings assumed.
