

Description 5.095 acre parcel

Being a part of the northwest quarter of Section 2, Salt Creek Township, T-14 N, R-12 W, Holmes County, Ohio, also known as a part of the lands conveyed to Rebecca Yoder, Trustee in Official Record vol. 175 page 1233 and Official Record vol. 267 page 47, PN 3400666000 and PN 3400701000.

Described as follows:

Commencing at a R.R. spike found in T.R. 616 marking the southeast corner of the northwest quarter of Section 2, thence S 89 degrees 45' 24" W 569.49 feet along the quarter section line and along T.R. 616 to a point the TRUE POINT OF BEGINNING, witnessed by an iron pin set N 00 degrees 27' 13" E 24.00 feet.

thence with the following FOUR (4) COURSES:

- 1) S 89 degrees 45' 24" W 398.56 feet along the quarter section line and along T.R. 616 to a 5/8 inch rebar found;
- 2) N 00 degrees 27' 13" E 556.90 feet along Nettie A. Yoder (Deed vol. 261 page 702) and Raymond L. and Laura Yoder's (Deed vol. 268 page 506) east line and partly along T.R. 615 to a point, witnessed by an iron pin set N 89 degrees 46' 15" E 22.73 feet;
- 3) N 89 degrees 46' 15" E 398.56 feet through the lands of said Rebecca Yoder, Trustee to an iron pin set;
- 4) S 00 degrees 27' 13" W 556.80 feet through the lands of said Yoder to the TRUE POINT OF BEGINNING.

This parcel contains 5.095 acres, but subject to all highways and easements of record.

The above described 5.095 acre parcel is granted the use of a 22 foot common access easement for the purpose of ingress and egress and further described as follows:


Thence N 00 degrees 27' 13" E 138.00 feet along the centerline of said 22 foot common access easement to a point and THERE ENDS.
