

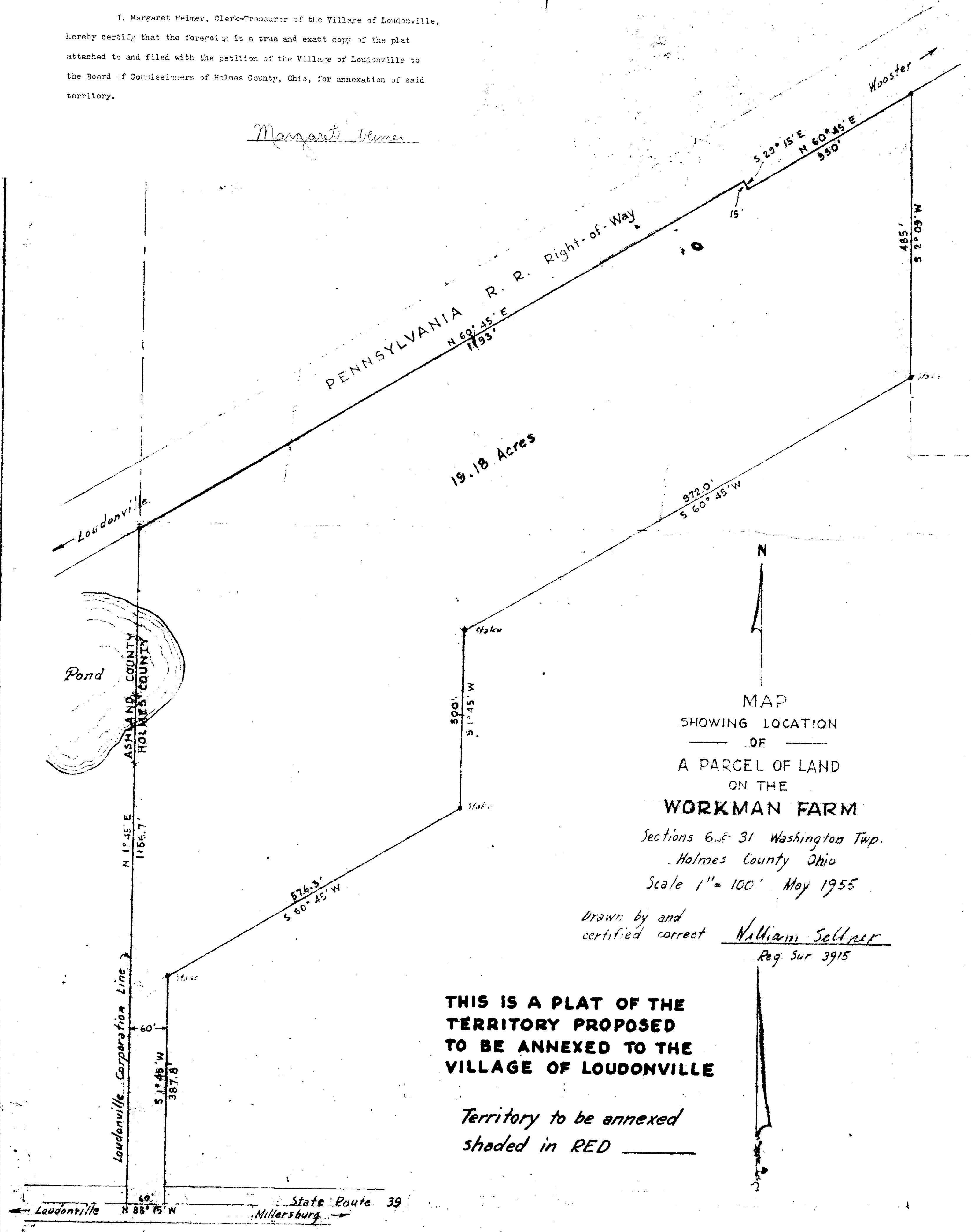

ORDINANCE NO. 564.

TO AUTHORIZE ANNEXATION OF CERTAIN TERRITORY TO THE VILLAGE OF LOUDONVILLE. BE IT ORDNANIED BY THE COUNCIL OF THE VILLAGE OF LOUDONVILLE, STATE OF OHIO:

Section 1. That the annexation of the following described territory being a parcel of land located in Washington Township, Holmes County, State of Ohio and being more particularly described as being a part of the southwest quarter of Section 31, and the northwest quarter of Section 6, Township 19, Range 15 in the district of lands subject to sale at Wooster, Ohio, and bounded as follows: Beginning at a point on the Holmes County-Ashland County line, said line also being the east Corporation line of the village of Loudonville, said point being at the intersection of the above described line and the south line of the right-of-way of the Pennsylvania R.R.; thence N 60 degrees 45' E along said Right-of-way line a distance of 1193 feet to a point; thence S 29 degrees 15' E a distance of 15 feet to a point; thence N 60 degrees 45' E a distance of 330 feet to a point; thence S 2 degrees 09' W a distance of 485 feet to a point; thence S 60 degrees 45' W a distance of 872 feet to a point; thence S 1 degree 45' W a distance of 300 feet to a point; thence S 60 degrees 45' W a distance of 576.3 feet to a point; thence S 1 degree 45' W a distance of 387.8 feet to the center of State Route 39; thence N 88 degrees 15' W along the center line of State Route 39 a distance of 60 feet to the intersection of the Corporation line of the village of Loudonville; thence N 1 degree 45' E along said line a distance of 1156.7 feet to the point of beginning and containing 19.18 acres, be and the same is hereby authorized.

Section 2. That the Solicitor be and he is hereby authorized to prosecute the proceedings necessary, to effect such annexation.

Section 3. This ordinance shall take effect and be in force from and after the earliest period allowed by law.
