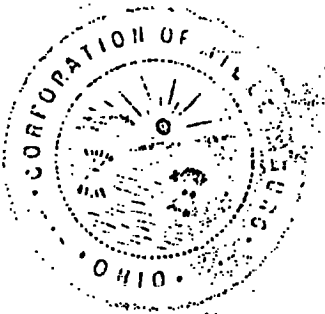
WHEREAS, it is in the best interest of the Village of Millersburg to accept the annexation of the aforesaid property.
